- 2.2 Focus Group 2: Strategising mobility, mobility in the context of institutional partnerships and joint/dual programmes and degrees (Montevideo – Octubre 2017)
- 2.3 Focus Group 3: Support services and general mobility quality tools (Sao Paulo – Noviembre 2017)
- Study Visit 1 - Governance and management of mobility programmes (Alemania – DAAD/TUB) (Diciembre??)

Preguntas para los grupos

WP3: (Development) - 'EU-South America mobility management practice sharing' (M12-M18)

- Lead: University of Coimbra
- Study visits to Europe (targeting different staff in partner universities), reflection focus group themes
 - Study visit 1: Berlin (DAAD and TUB hosted) – Governance of mobility programmes
 - Study visit 2: Bologna – strategising mobility, partnerships and joint degrees
 - Study visit 3: Coimbra – support services and mobility quality tools

Preguntas para los grupos

- The study visits are designed to reflect the focus group themes. Is this a good model?
- What do you think about the themes selected?
- How should the study visits be designed? Is it possible that the universities organise them in a way that participants can 1) see a specific case study of that university and b) get a sense of the national and regional context?

El 'Handbook'/Guia – en que consiste?

- *Synthesis* of exiting Latin American mobility programmes and agreements, rules of engagement and good practices in how they are administered.
- A section that targets **associations and networks** that govern regional mobility programmes
- A section targeting **universities** directly: strategic guidance on how to promote Latin American mobility to student and staff, a check list of good/common practices for managing mobility

'Piloting the Handbook' – En que consiste?

- Each South American partner university will design a pilot for the implementation of the Handbook in their institutions, according to their own interests and needs:
 - Pair up with a European partner and another LA partner to ensure peer support
 - Designate a coordinator .
 - Work plan for the pilot with specific objectives for what they want to improve or enhance in their institution and how the Handbook will guide this.
 - Outcome report
- Can include:
 - Setting up a new programme or cooperation for student and staff exchanges
 - A new promotion campaign for existing bi-lateral and multi-lateral programmes
 - Creating a web portal to promote all mobility opportunities with testimonials
 - Applying the management procedures outlined by the Handbook (learning agreements, recognition procedures)
 - Designing a new evaluation methods for mobility

'Piloting the Handbook' – En que consiste?

- *The job of the associations/networks*
- Developing a monitoring approach for LA mobility programmes
- Will include:
 - a common way of collecting information/data on students, staff and universities that participate in these programmes
 - ways of assessing impact of mobility (student tracking and employment, assessment of professors and staff members engaged, etc).
 - How to better coordinate and compare information on the impact of the LA mobility programmes in the future, across different countries and mobility schemes.
